On August 8, 2023, multiple wildfires ignited on the Hawaiian island of Maui. While the actual cause remains unknown, some speculate the fires started from a downed powerline. The wildfires quickly strengthened because of the dry conditions along with the wind. The fires burned across more than 17,000 acres destroying 2,207 buildings. According to some reports, the fires have burned at over 1000°F. Sadly, 114 people are confirmed dead due to the fires (As of 8/21/2023). Unfortunately, the number increases every day. More than 1,300 people remain missing. Aside from the loss of life, estimates for the damages are over \$6 billion. # TRUMP INDICTMENT BY: PHOENIX DANIEL


